**ORDER SETTING MATTER FOR TRIAL AND OTHER DEADLINES FOLLOWING
SCHEDULING CONFERENCE
(DOMESTIC RELATIONS)**

This matter, having come before the Court upon a request for a status conference, and the all parties having appeared through counsel as follows: Plaintiff ____; Defendant _____, and all parties having been heard, the Court hereby enters the following scheduling order:

1. **PLAINTIFF’S EXPERT DESIGNATIONS:** Plaintiff shall designate his/her experts by _____. Each expert shall be identified by a report signed by the witness listing the qualifications of each expert, each opinion the expert will present, and the basis for each opinion and otherwise comply with Wyo. R. Civ. P. 26(a)(2)(A) & (B) and all cases interpreting that Rule. Parties shall provide a brief description of any lay witness opinion testimony which does not require a report under Wyo. R. Civ. P. 26(a)(2).

2. **DEFENDANTS’ EXPERT DESIGNATIONS:** Defendant shall designate his/her experts by _____. Each expert shall be identified by a report signed by the witness listing the qualifications of each expert, each opinion the expert will present, and the basis for each opinion and otherwise comply with Wyo. R. Civ. P. 26(a)(2)(A) & (B) and all cases

interpreting that Rule. Parties shall provide a brief description of any lay witness opinion testimony which does not require a report under Wyo. R. Civ. P. 26(a)(2).

3. **DISCOVERY.** The discovery cutoff shall be _____. All fact witness depositions, document requests and requests for admission must be completed by this date. Written discovery requests are not timely if they are filed so close to this deadline that the recipient would not be required under Wyoming Rules of Civil Procedure to respond until after the deadline. Expert witnesses may be deposed up until three (3) weeks before trial. ANY WITNESS OR EXHIBIT WHICH HAS NOT BEEN PROVIDED TO THE OPPOSING PARTY PRIOR TO THE DISCOVERY CUTOFF MAY BE EXCLUDED FROM PRESENTATION AT TRIAL.

(A) **DISCOVERY DISPUTES.** To promote a just, speedy and inexpensive determination of discovery disputes, the Court will decide motions involving discovery disputes without a hearing (unless a hearing is specifically requested by the Court) upon the written submissions of the parties. At the time of filing of any motion, response, and/or reply, a courtesy copy of the filing and/or supporting memorandum shall be provided to the Court electronically in Word or WordPerfect format via e-mail at twr@courts.state.wy.us. The Court may disregard any filing by a party failing to comply with these requirements. Any motion seeking relief due to a discovery dispute shall contain a certification that, prior to filing the motion, the movant has in good faith conferred with the opposing person or party to resolve the discovery dispute before seeking court intervention and/or the opposing person's or party's position on the motion. In the event that the movant has been unable to confer with the opposing person or party to resolve the discovery dispute before seeking court intervention, then the movant shall certify a description of all good faith efforts taken by the movant to resolve the discovery dispute. Movant's failure to so certify will result in automatic denial of the motion. Any response to a motion involving a discovery dispute shall be filed within ten (10) days (as computed under Wyo. R. Civ. P. 6(a)) of the filing of the motion. Replies to responses are not expected, but if necessary to address new matters raised in a response, a necessary reply shall be filed within three (3) days (as computed by Wyo. R. Civ. P. 6(a)) of the filing of the responses

4. **DISPOSITIVE MOTIONS.** All parties shall file any dispositive motions pursuant to Wyo. R. Civ. P. 56 or otherwise by _____. Responses to dispositive motions shall be filed by _____. The parties may file reply briefs only with permission of the Court. The parties are reminded that all dispositive motions and responses shall include a statement of disputed or undisputed material facts as required under Wyo. R. Civ. P. 56.1. Such submissions shall contain proper citation to the summary judgment materials relied upon by the party for their claim that such a fact is disputed or undisputed. Although not required, the parties are encouraged to discuss and present joint undisputed material facts.

5. **ALL OTHER PRETRIAL MOTIONS** (including *Daubert/Kumho* motions, but not including other motions in limine) shall be filed by _____.

6. **FINAL PRETRIAL CONFERENCE.** The Court will conduct a final pretrial conference on _____, **scheduled for** _____, at the Campbell County Courthouse in Gillette, Wyoming. All counsel planning on appearing at the trial

of this matter shall be present. At least 14 days prior to the final pretrial conference, counsel for each party shall submit a final pretrial memorandum which shall include the party's: proposed child support calculations (if minor children involved); proposed joint summary asset/debt division; list of witnesses; list of exhibits, and; the party's contentions including any legal authority supporting such contentions.

7. **MOTIONS IN LIMINE** shall be filed with the party's Final Pretrial Memorandum.

8. **EXHIBITS.** The parties shall exchange trial exhibits by _____. Plaintiff shall mark all exhibits using numbers (i.e., Plaintiff's Exhibit 1, 2, etc.) and Defendant shall mark all exhibits letters (i.e., Defendant's Exhibit A, B, etc.). Joint exhibits shall be marked using the designation "Joint Exhibit No. ____."

9. **OBJECTIONS.** All objections to trial exhibits and/or witnesses shall be filed at least five business days before the Final Pretrial Conference including any objections regarding authenticity.

10. **TRIAL BRIEFS.** Any party may submit a trial brief. Such briefs, if any, shall be submitted no less than ten (10) business days before trial and shall be served on the opposing party.

11. **TRIAL** shall be held beginning on _____ continuing for _____ business day(s) at the Campbell County Courthouse in Gillette, Wyoming.

12. **AMENDMENTS TO THIS SCHEDULING ORDER.** DEADLINES WILL NOT BE CHANGED EXCEPT UPON GOOD CAUSE AND UPON WRITTEN ORDER OF THE COURT.
