Evaluation Criteria

1. Obtain an appointment for a _____ Evaluation at a licensed, certified treatment provider within 15 days of entry of Judgment and Sentence. The licensed, certified treatment provider must provide proof of the appointment within 48 hours of obtaining same to the Court. At the time of making the evaluation appointment, releases shall be signed by the defendant so the County Attorneys Office and the court may share with the licensed, certified treatment provider any information regarding the Defendant's prior criminal records if deemed appropriate.

2. At the time of making the evaluation appointment, releases shall be signed by the Defendant so the licensed, certified treatment provider shall send copies of any evaluations and recommendations to the County Attorney's Office and the County Attorney's office may share pertinent information with the licensed, certified treatment provider, and the licensed certified treatment provider may provide recommendations and compliance information to the County Attorney's office. If further evaluation or treatment is recommended, being treatment or obtain further evaluation within 15 days and provide proof immediately to the Court. Releases shall be signed by the Defendant at any licensed, certified treatment provider so the County Attorneys Office may share pertinent information with the licensed, certified treatment provider, and the licensed, certified treatment provider may provide recommendations and compliance information to the County Attorneys Office.
