Judicial Selection: Fifty-Two, Effective and Fair—But is **That Good Enough?**

Dan Kirkbride quietly and conscientiously served a four-year term on the Wyoming Judicial Nominating Commission, completing his service in January. Throughout his tenure, he focused on the task at hand—helping to thoughtfully vet 26 judicial candidates—without fanfare or public attention. He was never lobbied, seldom discussed commission matters socially, and took pride in the commission's careful, impartial work.

In January, however, interest in the state's judicial selection process took a notable turn when a group of mostly freshman legislators introduced a bill proposing that judges be elected rather than appointed. Although the bill did not advance, it sparked renewed public dialogue around a system that has been in place since 1972.

Since then, more voices have joined the conversation through opinion pieces, legislative discussions, and citizen engagement. This growing interest has led to important and fair-minded questions: Is anonymity in the selection process a strength or a limitation? Does the system's alignment with the legal community help or hinder public trust? Are concerns being raised reflective of broader national trends, or do they highlight unique local priorities?

As Wyoming considers these questions, many are asking whether the current system—long praised for its stability and effectiveness-might benefit from thoughtful updates, or whether its track record suggests that continuity remains the best path forward.

The bill died in committee, but the question remains: should shared custody be the default in custody cases in Wyoming, and, if not, why?




#### Rick Horowitz Prime Prose, LLC Shorewood, Wisconsin
