IT IS ORDERED:

1. July 1, 2024 - PLEA BARGAIN or DISMISSALS.

No plea agreement will be considered by the Court unless signed by all counsel and the Defendant, filed and brought to the attention of the Court on or before July 1, 2024. After that date, the Defendant may plead guilty to all offenses charged in the information with the understanding there is no sentencing agreement; the information may be dismissed; or the matter will be tried.

2. April 9, 2024 - MOTIONS.

Reasonably anticipated motions and supporting material shall be filed and served. The receiving party's written response is due within ten (45) days from the filing date of such motions.

3. May 23, 2024 - TRIAL BRIEF.

Counsel shall prepare, exchange and file a trial brief including:

a. **WITNESSES.** List witnesses that may be used in your case in chief by name and address. Include a brief summary of the testimony of each. (Defendant is excluded from list).

b. **EXHIBITS.** List intended exhibits. Furnish copies to opposing counsel, or if not feasible, make them available for inspection. Unless written objection is filed within five (5) days from the list filing date, listed exhibits will be admitted if relevant. (State uses numbers. Defendant uses letters.)

c. **CONTESTED ISSUES OF LAW.** Describe these, if any, citing authority for

counsels' position.

d. MISCELLANEOUS. Mention other concerns.

4. June 6, 2024, at 9:00 a.m. - PRETRIAL CONFERENCE shall be held at the Sheridan County District Courtroom in Sheridan, Wyoming. Unresolved motions shall be heard at this time.

5. June 6, 2024 - JURY INSTRUCTIONS.

No jury instructions should be filed with the clerk until the jury instruction conference during trial. However, at or before the pretrial conference the parties shall submit for the Court's view a set of STIPULATED JURY INSTRUCTIONS. The instructions shall have a cover sheet index and shall be unnumbered - suitable for presentation to the jury. See Rule 403 of the Uniform Rules for District Courts.

Also, at or before the pretrial conference contested, proposed instructions should be submitted for the court's view - in duplicate with the first being "clean and unnumbered" suitable for presentation to the jury and the second annotated. (Be sure to include a proposed verdict form.)

Contested proposed instructions will either be used by the Court or filed as "refused" at trial.

6. July 5, 2024 - DISCOVERY.

All reasonably anticipated discovery shall be completed.

7. July 15, 2024 at 9:00 a.m. - JURY TRIAL (12 persons)

Trial will be held in the District Courtroom of the Sheridan County Courthouse, Sheridan, Wyoming. Two (2) days have been set aside for trial.

(THIS CASE IS STACKED #5. Counsel must apprise themselves of prior case status.)

Counsel and the Defendant shall be personally present for every hearing in this case and shall report to the Court's office at 8:30 a.m. on the first day of trial. Counsel shall strictly comply with deadlines set forth.
