STANDARD VISITATION SCHEDULE

Second Judicial District Court of Wyoming – Carbon County

- 1. General Governing Conditions. The following priority system will control:
 - (A) This standard visitation schedule is intended to be the minimum amount of visitation time for the non-custodial parent. When the parents can agree upon additional or different visitation than that set forth here, such alternate visitation will take precedence, but only for so long as the parents continue to agree upon the alternate visitation.
 - (B) Whenever a school holiday period is referred to herein, it means the child(ren)'s actual holiday or vacation period when they are in school. If the child(ren) is not in school, the period will be the school vacation or holiday period as used by the schools in the school system where the child(ren) resides with the custodial parent.
 - (C) Holiday visitation for either parent will have precedence over weekend visitation, but will not otherwise modify the visitation schedule. (For example, if the holiday granted in any particular year to the non-custodial parent falls between alternating weekend visitations, then the non-custodial parent will have visitation for three (3) weekends in a row.)
 - (D) Holiday visitation for either parent will take precedence over summer visitation periods, but will not otherwise modify the visitation schedule.

2. Alternating Weekend Visitation. The non-custodial parent is entitled to visitation every other weekend with the child(ren), commencing at 5:00 p.m. on Friday and ending at 5:00 p.m. on Sunday, unless Monday is a school holiday in which case weekend visitation shall extend to Monday at 5:00 p.m.

3. Holiday Visitations in Odd-Numbered Years. In odd-numbered years, the non-custodial parent shall have the following holiday visitations:

- (A) Memorial Day Weekend, commencing at 5:00 p.m. on the Friday before Memorial Day and ending at 5:00 p.m. on Memorial Day.
- (B) Thanksgiving, commencing at 5:00 p.m. the day school lets out and ending at 5:00 p.m. on the Sunday after Thanksgiving Day.

(C) Second part of the Christmas/Winter Break, commencing at noon on December 26th and ending at 5:00 p.m. on the last day of the school holiday.

4. Holiday Visitations in Even-Numbered Years. In even-numbered years, the non-custodial parent shall have the following holiday visitations:

- (A) Spring Break or, alternatively, Easter Weekend. If the child(ren) has a Spring Break, the non-custodial parent shall have visitation during that break commencing at 5:00 p.m. on the day school lets out and ending at 5:00 p.m. on the last day of the school holiday. If the child(ren) does not have a Spring Break, the non-custodial parent shall have visitation during Easter Weekend, commencing at 5:00 p.m. on the day school lets out and ending at 5:00 p.m. on Easter Sunday.
- (B) Labor Day Weekend, commencing at 5:00 p.m. on the Friday before Labor Day and ending at 5:00 p.m. on Labor Day.
- (C) First part of the Christmas/Winter Break, commencing at 5:00 p.m. the day school lets out and ending at noon on December 26th.

5. Mother's Day and Father's Day. Mother shall always have visitation on Mother's Day, commencing at 10:00 a.m. and ending at 5:00 p.m. Father shall always have visitation on Father's Day, commencing at 10:00 a.m. and ending at 5:00 p.m.

6. Summer Visitation. During the child(ren)'s summer vacation from school, the custodial parent shall have the child(ren) uninterrupted during the first ten (10) days of vacation and the final ten (10) days of vacation. The non-custodial parent shall have visitation the remaining time, with the custodial parent having visitation every other weekend (from 5:00 p.m. on Friday to 5:00 p.m. on Sunday) during the non-custodial parent's summer visitation block.
